Steps Toward Achieving Results (STAR)

- To be eligible, your clients' household income must be less than or equal to the county/city HUD median income
- No mortgage insurance even at 100% LTV
- Up to 100% financing with a minimum qualifying credit score of 700
- Grants for closing costs may be available
- Minimum borrower contribution lesser of \$500 or 1% of sales price
- Borrowers cannot have any prior bankruptcies, unpaid collections or judgments (past due accounts must be brought current)
